LEAs serve all students, including students with disabilities, to achieve the highest level of learning and performance, finishing school, and become successful members of their community and the workforce. AEAs provide support services to every public and accredited non-public school in lowa, and work closely with families to meet the needs of their children, including children with disabilities.	WIPA serves Social Security beneficiaries ages 14 to 65 who receive Social Security Disability Insurance (SSDI) and/or Supplemental Security Income (SSI), who want to pursue gainful employment.	The IVRS intermediary program serves high school students with disabilities in designated districts.
Services Provided	LEAs are able to provide special education services, which involves specially designed instruction tailored to the unique needs of each child, and is provided at no cost. For students qualifying for special education, the goal of the Individualized Educational Program (IEP) process is to direct the student toward high expectations and becoming a successful member of his or her community and the workforce. Students with disabilities who do not require specially designed instruction to meet their educational needs may be served with a 504 Plan. A 504 plan defines the accommodations that a student needs to access educational services in the general education setting. Special education is a broad term that describes the education of students who have intellectual, physical, behavioral or emotional disabilities. AEAs make sure all students have lifelong access to high-quality educational opportunities and resources. They also provide a wide variety of tools for educators to grow professionally and reach students.	Provide accurate information to beneficiaries receiving Social Security Disability Insurance (SSDI) and/or Supplemental Security Income (SSI) and the work incentives available under these programs. This information will help individuals to make informed choices about employment/self-employment including: how available work incentives can facilitate their transition into the workforce; and Information on the impact of earnings on other support programs.
